

Music Licensing Basics For Brick and Mortar Business Owners

If you own a business with a brick and mortar storefront and play background music for your customers or patrons to enjoy, there is a good chance you are violating federal copyright law. While most business owners don't realize it, music is a form of intellectual property, and it is illegal for a person or business to utilize intellectual property created and owned by another without obtaining permission first. Permission may be obtained in a number of ways, but the most common method is through licensing.

Obtaining a license for music is very simple. Remember when you bought that Maroon 5 album on iTunes last month? When you paid for it, you were purchasing a perpetual license to listen to each of the songs on the album. The licenses you obtained, however, are very narrow and specific, because they only apply to you personally. In other words, you do not have permission to go play the Maroon 5 album as background music for the customers in your store, or patrons at your bar.

Playing music for your customers, regardless of the method (via iTunes, compact disc, mp3, etc.), requires a different type of license called a public performance license. Although public performance licenses come in a variety of different packages (depending on a person's/business' needs), the underlying purpose is essentially the same across the board: it gives the licensee permission to play music to a large group of people in a public setting.

Public performance licenses are acquired through Performance Rights Organizations. In the United States, there are four primary agencies: (1) the American Society of Composers, Authors, and Publishers ("ASCAP"); (2) Broadcast Music, Inc. ("BMI"); (3) the Society of European Stage Authors and Composers ("SESAC"); and (4) SoundExchange. Each of the aforementioned Performance Rights Organizations offers licenses that enables the licensee to publicly perform/play music. Unfortunately, acquiring the rights to play a song in your brick and mortar store is not always as simple as purchasing a blanket license from one of these organizations.

Excluding SoundExchange, songwriters and composers may only register with one of the three main Performance Rights Organizations (ASCAP, BMI and SESAC). Two problems arise as a result: (1) obtaining a blanket license from one of the main Performance Rights Organizations only grants a public performance right in songs that are included in that Performance Rights Organization's catalog - therefore an ASCAP license may provide a public performance license for songs written by The Beatles, but not anything written by The Beach Boys (who are registered with BMI); (2) when a song is co-written (in terms of lyrics or composition) by two or more people registered with different Performance Rights Organizations, a license from one organization will only grant a public performance license with respect to the rights owned by the writer or composer registered with that organization – in other words, it may be necessary to acquire licenses from multiple Performance Rights Organizations just to play one song. It is also worth noting that the type of public performance license that needs to be obtained is dependent upon the method in which the music is being transmitted. For example, if a business wanted to play music through a streaming service, such as Pandora, it would need to acquire a commercial license

from Pandora. Proceeds from the Pandora commercial license would go to SoundExchange. With that being said, unless the streaming service being used offers a commercial license, playing music from a streaming service in a commercial setting would be illegal. Keep in mind, a public performance license is needed even if a business only has live music (rather than recorded), unless the music being performed is completely original.

Regardless of whether you just opened your business or if you have been in business for decades, it is critical to obtain the appropriate licenses if you are playing music for your customers/patrons. Although there are specific thresholds for determining what qualifies as a public performance, generally speaking, the vast majority of businesses fall within the boundaries of the term. In addition to managing the licensing of public performance rights, Performance Rights Organizations also actively monitor and enforce the rights of their members by demanding payment and/or successfully suing violators. Ignorance of the law is not a defense, so failure to obtain the appropriate rights can cost a business thousand and thousands of dollars.

Needless to say, intellectual property law, especially in the music industry, is extraordinarily complex, and needs to be navigated very carefully. Blanket licenses are powerful and effective tools for businesses that want to use music to entertain customers. To that end, however, it is critical to ensure the correct licenses, in terms of both the number and type, are obtained, so that the Performance Rights Organizations do not take legal action against you or your business. If you are uncertain whether your business is in compliance or what type of licenses your business may require, you should seek the assistance of an entertainment attorney.

The recipient shall be someone who 1) has actively helped his/her community, 2) demonstrates devotion to the general welfare of the community, 3) looks first at what they can do for others and their community, 4) is a leader capable of getting others involved, 5) has demonstrated extensive and diverse participation, leadership and support in public and/or private civic endeavors over a period of years. All selections are made without regard to race, color, creed, gender, age or national origin.

Lake Health Seeking Companies and/or Individuals To Participate in 11th Annual Be Fit For Life Fitness Challenge

CONCORD TOWNSHIP, Ohio, September 8, 2016—Lake Health is recruiting local companies and/or groups of 10 or more individuals to participate in the 11th annual Be Fit For Life Fitness Challenge, a challenge in which area businesses or groups of individuals compete for the most points as they exercise their way to better health.

The four-month initiative, which will kick off January 1, 2017, was developed through a partnership with the Lake Metroparks, the Lake County YMCA and the Lake County General Health District. Each month, the challenge will feature a main fitness event as well as a diverse array of activities, each with a specific point value. The goal of each team is to attain full participation from every team member, therefore earning the maximum number of points. Teams that earn the most points are eligible to win the grand prize.

Companies and/or groups of individuals interested in participating can attend an information meeting on Wednesday, October 5 at 4 p.m. at TriPoint Medical Center, Private Dining Room, 7590 Auburn Road, Concord Township.

This year's challenge includes both competitive sports and recreational activities, such as walking, cross-country skiing, band camp, snowshoeing and archery. For many participants, the Be Fit For Life Fitness Challenge provides the opportunity to try new activities and further explore the many trails and recreational facilities that comprise Lake Metroparks.

In addition to scheduled group events, participants can also select individual activities to do on their own. This flexibility gives even time-deprived challengers the opportunity to participate and enables family members to get involved. While they are not eligible to earn points, spouses and children can exercise along with Be Fit For Life participants, providing additional encouragement and motivation.

When the Be Fit For Life Fitness Challenge concludes on April 30, 2017 points will be tallied and the grand prize will be awarded to the winning team. The winning team also will receive Lake Health's "Heart of the Community" award.

council of smaller enterprises 4 Ways to Be a Better Leader

What traits do you think of when you consider what makes for an effective leader? During a recent Small Business Boot Camp session, Jeff Nischwitz of The Nischwitz group took a deep dive into the qualities all leaders share, and how those characteristics can help a small business—and its staff—thrive. Below are 4 takeaways from the presentation.

1. Know Yourself

Entrepreneurs need to understand what kind of leader they are striving to be. And as part of that discovery, should ask themselves three questions:

What kind of leader am I committed to becoming?

Am I willing to let go of how things have always been done?

Can I tolerate living outside of my comfort zone?

2. What Not to Do

Leadership is not bullying. It is not about being disengaged. What is it about, then? Continue reading ...

3. Be Accountable

A leader has to have the trust of their staff. Being accountable is one way to build trust, but what are the others? Try being human:

Ask for feedback.

Admit mistakes.

Be honest if you don't know the answer to something.

Don't be afraid to ask for help.

Allow staff the freedom to challenge perceptions.

Understand the '3 I's of Leadership.'

4. Be Conscious

Remember back in the second item that talk about being disengaged? A Gallup Survey found that 70% of employees are not engaged with their work and employer. The steps outlined above will go a long way toward helping eliminate a leader's blind spots and increase team engagement. It's important that leaders take a "conscious" leadership position, that is, be aware of not only the needs of their staff but also to honor their staff's perception of their leadership. And if you want to know more about conscious leadership, check out Nischwitz' book: "Unmask: Let Go of Who You're Supposed to Be & Unleash Your True Leader."
