- Entry must be able to fit on a table top or if furniture, be no bigger than 6' wide.
- There is no entry fee. You may enter more than one item. Each item entered must have its own contest entry form.
- Each entry must include a before photo along with an entry description of what was done.
- You are responsible for drop off and pick up of your entry. All items must be picked up at 6:00pm on Saturday, March 7th, the close of the display.
- You are able to put out your contact information and if the item is for sale, the price and information for people to contact you must be provided in printed format.
